Scammers focus on law firms (and most every business, really) such as ours by using fake email addresses (this is known as spoofing). **If you look closely at the FROM address, the name says JOHN F. ROBBERT, but the e-mail address is NOT our address** (username@ChesapeakeLegalCounsel.com)! E-mail from our office will ONLY ever come to you from our official addresses. If it seems suspicious, just delete it and/or give us a call.
