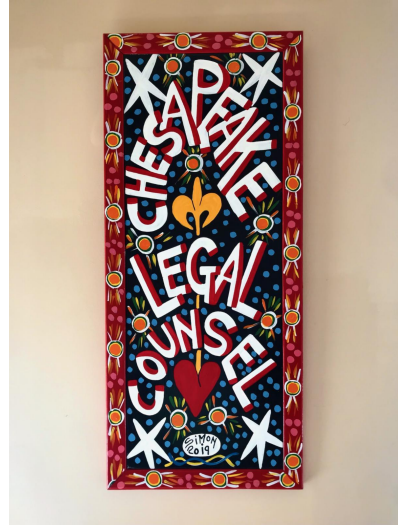

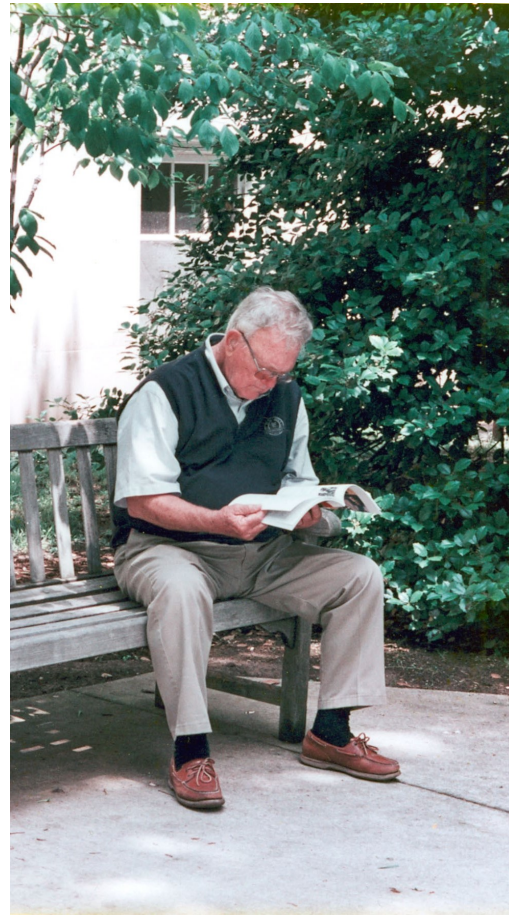


Anahi Rizo Sanchez
