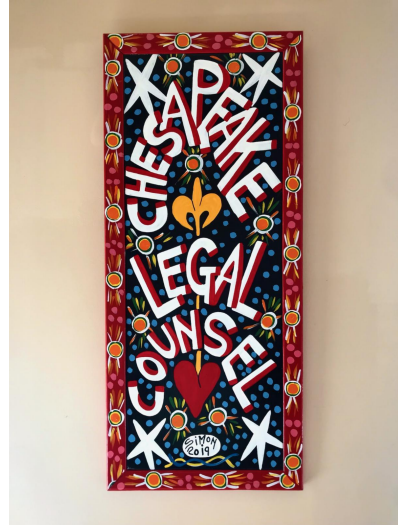

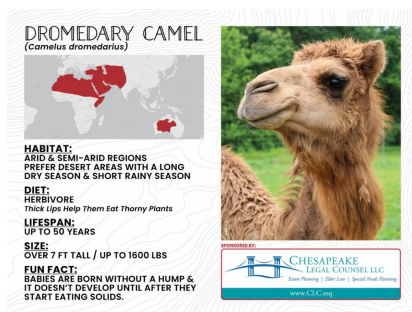

Intent to File PACT Act Claim Deadline: Wednesday, August 9, 2023

If you, a spouse, or a family member were or might have been exposed to burn pits, Agent Orange, or other toxic substances during Vietnam, the Gulf War, or post-9/11 eras, **you only have until Wednesday, August 9, 2023 to file a notification of intent to file claim with the VA.**

As of August 10, 2022, a long list of new conditions are presumed to be service-connected due to various in-service toxic exposures. VA encourages

all eligible Veterans and survivors to file a claim—or submit their intent to file a claim—for PACT Act-related benefits NOW at VA.gov/PACT. Most Veterans who do so by August 9, 2023, will have their benefits, if granted, backdated to Aug. 10, 2022 (the day President Biden signed the bill into law).

If you haven't filed a claim yet for the **presumptive condition**, you can file a new claim online now. You can also file by mail, in person, or with the help of a trained professional. If you had **previously filed but were denied by the VA**, you can now file a Supplemental Claim, but again the **notification of intent to file MUST be filed by August 9, 2023!**
