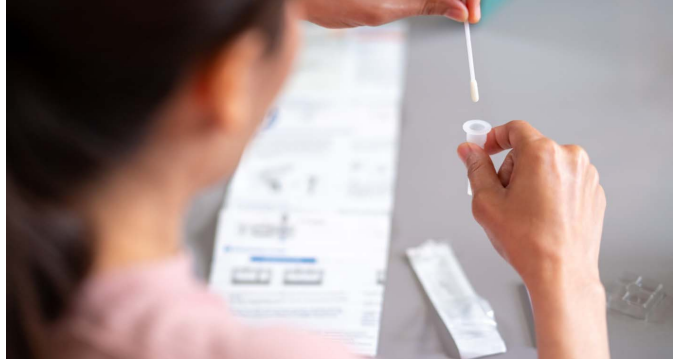

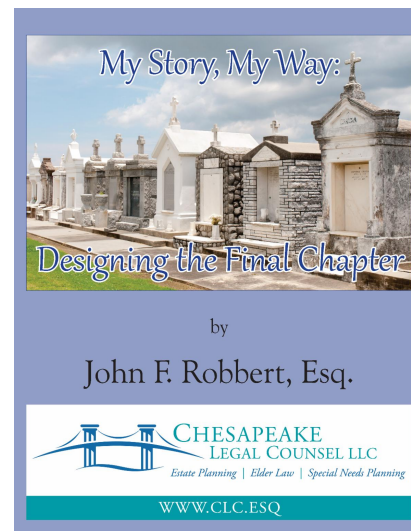
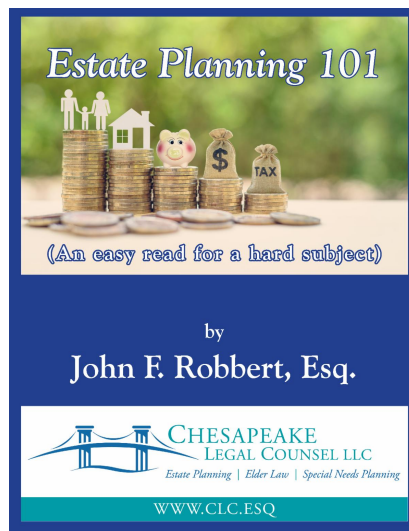
Production Manager for the Entertainment Department.
